The meeting of the Board of Directors was called to order at 7:00 pm by Director Miller

I. GENERAL PUBLIC COMMENT

No public comment.

II. PUBLIC HEARING

PH1. Adopt a Final Budget of the Woodside Fire Protection District for the Fiscal Year 2024-2025

Director Miller opened the public hearing on the final budget. No public comments were received. Director Miller closed the public hearing.

Director Miller addressed a notable increase in line 5733, related to fire prevention, which appears to have risen significantly by \$438,600. This apparent increase is not an actual rise in expenditure but rather an accounting adjustment. Last year, the District accounted for incoming revenue, such as grants and repayments, which offset a substantial portion of this expenditure. This resulted in a net expenditure of \$138,284 last year. However, this year, the District did not net out these offsets, which creates the optical illusion of a higher expenditure. Internally, the actual spending has not increased as much as it appears on paper, so there is no cause for concern.

Director Miller also highlighted the persistently high workers' compensation costs. Various strategies are being explored to address this issue, as discussed in previous meetings. Actions already taken include changing our insurance model and improving internal procedures. While the

directors have not identified additional measures to control these costs, they are actively monitoring the situation and will continue to do so.

Additionally, there are increased budget items due to the new station, which includes higher maintenance costs for HVAC systems and other facilities that require upkeep to maintain their quality. Finance Manager Liu previously reviewed these budget items, and the increases are associated with the new station's operational needs.

Director Holthaus made a motion to Adopt a Final Budget of the Woodside Fire Protection District for the Fiscal Year 2024-2025 as presented, 2nd by Director Foster. Motion passed 3-0.

Director Holthaus motioned to approve the consent agenda and approve Items C1, C2, C3, C4, C5 and C6 with modifications to C3, as presented. It was noted that there was an Excel error in the December hard number column that showed an incorrect cash and reserve balance which was corrected, 2nd by Director Foster. Motion passed 3-0.

Director Holthaus made a motion to Finalize Approval of Budget of the Woodside Fire Protection District for the Fiscal year 2024-2025, Director Foster 2nd. Motion passed 3-0.

Director Holthaus made a motion to Adopt Resolution 24-09 "Fixing the Employer Contribution under the Public Employees' Medical and Hospital Care Act at an Equal Amount for Employees and Annuitants", Director Foster 2nd, Motion passed 3-0.

R3. Adopt Resolution 24-10 "Resolution Authorizing Transfer of Funds for Capital Building Reserves"

No public comment was received on this item.

Director Holthaus made a motion to Adopt Resolution 24-10 "Resolution Authorizing Transfer of Funds for Capital Building Reserves", 2nd by Director Foster. Motion passed 3-0.

R4. Adopt Resolution 24-11 "Resolution Establishing Appropriation Limits for the Woodside Fire Protection District"

No public comment was received on this item.

Director Holthaus made a motion to Adopt Resolution 24-11 "Resolution Establishing Appropriation Limits for the Woodside Fire Protection District", 2nd by Director Foster. Motion passed 3-0.

R5. Adopt Resolution 24-12 "Resolution Authorizing Transfer of Funds for Equipment"

No public comment was received on this item.

Director Holthaus made a motion to Adopt Resolution 24-12 "Resolution Authorizing Transfer of Funds for Equipment", 2nd by Director Foster. Motion passed 3-0.

V. STAFF REPORTS

Director Miller expressed enthusiasm about the Ember House demonstration, noting that it was both engaging and educational. He suggested that such demonstrations should be a regular feature at town council meetings, especially when discussing topics related to building safety. The demonstration was particularly illuminating, showcasing how certain materials, such as rubber, can become highly flammable.

Director Miller also mentioned a concern regarding the generator that was revealed to be insufficient during the demonstration. He inquired about our short-term and long-term plans for addressing this issue, especially since it was not included in the current budget. He acknowledged that resolving this matter may involve significant costs.

During the course of the remodel, Chief Cuschieri reported that the generator was found to have several issues. The generator, which has been in place for as long as Chief Cuschieri can remember and has never been replaced, was identified as overdue for replacement. It currently does not power everything at the station, and during a power outage, certain essential items that require power are not functioning.

An initial estimate was obtained from REG, the company that performed electrical work at both stations, which was approximately \$400,000. However, Chief Cuschieri received a subsequent estimate from CJW that was significantly lower at \$163,000. The substantial difference between these estimates necessitates further review.

Chief Cuschieri indicated that further follow-up is needed to address the discrepancy and that due diligence will involve evaluating several bids before making a decision. Additionally, the expense was not included in the current fiscal period's budget, so there is a plan to consider deferring the project to the next fiscal period.

VI. FIRE CHIEF'S REPORT

District Updates

- On July 23rd the Fire District, along with 4 other agencies in the County, sent resources to assist with suppression efforts with the Park Fire in Butte County, which has burned over 429K acres. Our crews returned after spending a total of 21 days at this event. As of today, this fire is now 85 percent contained.
- At last week's Foundation meeting the Foundation Board agreed to help fund the Districts new Mental Health and Firefighter Resilience Program our team is putting together. This program will be designed to integrate educational workshops, peer support, counseling services, critical stress management and resilience training to help prioritize mental health within our department. Chief Cuschieri would like to thank the Foundation for the 35K to help start the program.
- Earlier this month Chief Cuschieri was approached by Denise Enea and Fire Safe to write a letter to help support a grant they are applying for. The grant is through the State Coastal Conservatory for 285K. If awarded the funds will be used to remove the rest of the eucalyptus trees on the Sandhill Evacuation corridor. This has been submitted and is awaiting approval.

Recognition

• Woodside Fire Retirement dinner will be on November 16th at the Mounted Patrol Grounds. This will be to honor retired members Fire Chief Rob Lindner, Fire Marshal Don Bullard, Battalion Chief Steve Slaughter, Battalion Chief Farrell Smith, and Finance Manager Kate Edwards.

Station 7 T-Mobile Update

• No status change with T-Mobile. They've submitted updated plans to the Town for relocation of the ground mounted infrastructure. The project team indicates about 6 months until the monopole is up and running then the COW will be removed.

San Mateo County Updates

- At the County Chief level we are continuing to work with our consultant AP Triton on data submissions for the EMS Study we are conducting. This should be complete in the next 4-5 months.
- This data will provide an overall value of the County EMS system which will help us decide if the value is worth submitting a bid for the next RFP. The contract between AMR and the County expires in 2029.

State Fire Updates

• As of today there has been a total of 5,563 wildfires in the state which have burned a total of 832,337 acres. This includes 1,247 structures that have been either damaged or destroyed.

Overview

September has been a month of significant progress and accomplishments for our EMS division. As we continue to prioritize excellence in patient care and operational efficiency, we have achieved several milestones worth highlighting.

Certification Achievement

Firefighter Scott Lory has passed his National Registry Paramedic exam and is now in the process of completing his 5-call for San Mateo County accreditation. Once complete, Scott will be certified to practice in the county as a paramedic for WFPD. Scott will be assisted through this process by Firefighter Paramedics Erik Lohmann and Josh Muela. Congratulations to Scott!

Certification Achievement

Firefighter Paramedic Zack Martin has completed his Paramedic FTO process and is now a certified "stand-alone" paramedic with WFPD. This additional training and testing proves one's abilities as a capable and competent paramedic, certifying them to work as the sole

paramedic on a fire engine and manage patient care individually. Zack was evaluated throughout this process by Firefighter Paramedic Nick Passanisi. Congratulations, Zack!

Lifepak Monitor Equipment Trial

The EMS Division has taken delivery of a new Lifepak 35 cardiac monitor to trial, in anticipation of future use by San Mateo County. Used in training only (not on 911 responses), WFPD paramedics have been able to explore the advancements made by Stryker, including a larger, high-definition touchscreen, improved CPR functions, and better water and impact protection. Further trials and discussions are expected in San Mateo County EMS, but our paramedics have been very excited about the future of our EMS equipment!



Conclusion

September has been another productive month for the EMS division, marked by significant advancements in training, equipment, and operations. These developments collectively enhance our service delivery, ensuring we remain at the forefront of pre-hospital emergency care.

I am proud of the dedication and hard work demonstrated by our EMS personnel in completing the training and adapting to new equipment and systems. We will continue to monitor the impact of these changes and strive for continuous improvement in all aspects of our operations.

Woodside Fire Protection District Operations Division Report August 2024

Battalion Chief Vince Nannini

The Woodside Fire Operations Division roles and responsibilities are to provide an efficient safe operating strategy that adheres to County and District Policies and Guidelines. We also maintain our fleet and all associated tools and equipment to maintain a constant state of readiness. To respond not only in our fire district but throughout the County and State. The Operations Div. is also responsible for the Health and Wellness program, Safety Committee and loss reduction. Which contributes to the organization's success.

The Operations Division helps support a multitude of different areas within our organization to help accomplish our many goals. These areas include Prevention and Fuel Mitigation support, manages our Single Resource program and equipment, Recruit Academy support, The Operations Division Chief, while on shift, also sits on committees such as SMCO Operations Committee, Safety and Loss Reduction committee and Apparatus committee.

Below is the status of the fleet and equipment status and an update of ongoing projects for the month.

Woodside Fire Operations

A. Apparatus Committee: -

- 1. The Committee is in the process of a designing a Type3 fire apparatus. We plan on using the CAL Fire specification and trying to get in on an order with them to keep cost down. Hope to present it to Command Staff in Oct.
- 2. We have a solution for our issue with "buddy breathing" with the new Scott air-packs. Training has been completed and we are waiting on two more adaptors.

- 3. We have reached out to CAL Fire and have started a conversation on acquiring WT57 from LaHonda Fire. CAL Fire has agreed to allow WFPD to operate that unit for 2-3 years until they can complete construction on Station 59. The transfer of the water tender should take place in Oct. Nov. time frame.
- 4. OOC equipment has been inventoried and is in ready status for any deployment.
- 5. The Pierce manufacturing plant have began construction on new Engine 7. Anticipating a 6-8 month build time. We are still moving on schedule.
- 6. Apparatus Committee's next meeting 09/17/24.

B. Vehicles:

- 1. Eng. 8 is back in-service.
- 2. Eng. 19 is getting plumbing work completed and should be inservice the week of the 23rd of Sept.
- 3. The reserve Rescue has been serviced and new breaks installed and is back in reserve status.
- 4. WT 108 is in for transmission work, it should be back mid Sept.

C. Shift Work:

- 1. Wildland preparation continues as we are entering the height of the season.
- 2. Training on our new low-pressure nozzles has been completed and a flow test has also been completed. The calculations for a new pump chart are also being worked on.

Woodside Fire Protection District Logistics Division Board Report August 2024 Battalion Chief Robert Douthit

The Woodside Fire Logistics Division exists to provide oversight and organization to the maintenance and welfare of all Woodside Fire Protection District facilities, as well as the technology platforms necessary for our daily operations. We strive to provide the most current and relevant technologies and equipment to all our facilities and apparatus ensuring that our employees have everything they need to serve our community at the highest standard. We maintain our stations in a manner that would make the citizens we serve proud, and we ensure the safety of all who work in and visit our stations daily. We research and apply for grants with both federal and local governments to leverage available public funds to help augment the budgets needed for our mission and the collective mission of the WFPD. The Logistics Division continually looks for new methods to keep our facilities and our technological and operational capabilities current with industry best practices of the modern fire service as well as plans and anticipates for the operational growth and technological advancements of the future.

Facilities

Station 7:

- The maintenance of the HVAC Systems in both stations 7 and 8 were completed by Silicon Vally Mechanical. This is a new contract that will see the new systems maintenanced every 6 months.
- The re-keying project quote came in with an unanticipatedly high cost, so the vendor was negotiated with, and the cost of the project was reduced by 25%. The project scope will also be scaled back at station 19 for additional savings with the mission critical work still to be performed at all three stations. The work will begin in September.
- The Executive Casework group is still working on the items for station 7:

 a mail center, bookcase for the library and a coffee/beverage station for
 the rear classroom foyer.
- Shower glass was installed at both stations 7 and 8 in the new bathrooms. The two stations were relying on shower curtains and the new shower glass not only creates a more comfortable shower environment but will also help to prevent long term moisture damage to the new bathrooms.
- Redwood Electric Group (REG) completed work to allow for an additional response acknowledge button outside of the battalion chief bedroom. This button mirrors the others on the west side of the station that are used by the firefighters and captains. Jim Gronke of TEA will complete the work with the button installation and associated testing in September.
- Vance Brown added an additional drain line to the turnout extractor eliminating the leaking problems caused by the single floor sink.

Station 19

- The plans for the replacement of the fire alarm control panel have been submitted to the WFPD Prevention Bureau and are currently being reviewed.
- The second phase of the landscaping project has been planned and will be completed in September. The remainder of the work includes adding weed cloth and decorative rock to the (now) empty planters in the station's zero space as well as replacing some of the gravel groundcover on the perimeters of the station.

Station 8

• Station 8 was faced with a critical challenge as the water main to the station spontaneously ruptured on Saturday August 3rd and cut all potable water supply to the station. Thanks to the quick action of the on-duty crew of four the problem was quickly identified; the water was shut off and very little property damage occurred. Vance Brown (VB) was contacted as the work fell under the station warranty and a plan was devised by KDS plumbing and Preston Pipelines the following Monday to repair and replace the water line. The VB crew also installed a temporary water line that provided non-potable water to the station for the duration of the project. The new line constructed bypassed the old underground infrastructure entirely going up and over the station roof instead. The new water line was completed by the end of the week and an additional week was required for the break-in and sanitization of the new water line. In the meantime, the ever-resourceful firefighters

- of station 8 made do with a combination of bottled water and a rented bathroom trailer.
- Station 8's dishwasher was replaced after many years of gallant service.
- Executive casework continues its work to plan the new bedroom lockers. They have not committed to a completion date.

IT Update:

- Stepford continued its daily work to keep us operating and secure.
- The Green Team are working to print additional copies of our station maps and target hazards and continue work on our mapping and preplan projects.

Grant Opportunities

The FEMA Assistance to Firefighters grant program continues to announce its grant awards for the 2023 cycle, WFPD has not been notified of an award or rejection yet.
