**Operations Apparatus:** B/C Lindner reported the Rescue 7 is being staffed approximately 50% of the time. Data is being gathered of the call volume for the Rescue. Firescope is gathering data on Fire Agency apparatus. This data bank will type all apparatus and make it more efficient to order strike teams. The County station ordering has been updated to 50 deep ordering of apparatus. Workers compensation is slowly reducing and sick leave for last month was up.

**Operations Facilities:** B/C Nave reported that the web site has been very active. There are daily updates that are conducted by the District. Telestaff and computer maintenance accrued approximately 10 hrs. The response block update accrued 31 hours of overtime. The new HVAC units have been installed at station 7.

**EMS:** B/C Picchi reported that FF/Paramedic is becoming more involved in the EMS training in the County. FF/Paramedic Michael Lambrechts and CERPP coordinator Selena Brown continue to assist with the CPR and AED classes.

**Training:** B/C Butler reported that 8 employees are preparing for probationary testing. Preparing for upcoming wildland drill. Processing applications for entry level firefighter/paramedic. The new application has been updated to a digital format.
